

TAX PAYMENT OPTIONS

- **By mail. Include a telephone number where the treasurer can reach you with questions. If you would like a receipt, you must include a self-addressed stamped envelope. Mail checks to:**

- **Payments can be made at any time by using the drop box located by the main entrance. Include your telephone number. If you would like a receipt, you must include a self-addressed stamped envelope.**

Please note that December 31st lands on a Sunday this year. Plan accordingly if you choose to pay prior to year-end.

HELPFUL HINTS

- **FOLLOW THE INSTRUCTIONS ON YOUR TAX BILL CAREFULLY-ALL *1ST* INSTALLMENT OR PAYING IN FULL CHECKS SHOULD BE MADE OUT TO TOWN OF WATERTOWN.**
- **MAKE SURE AMOUNTS ON YOUR CHECK/S ARE CORRECT.**
- **REMEMBER TO SIGN YOUR CHECK.**
- **REMEMBER TO ENDORSE YOUR ESCROW CHECK IF IT IS MADE OUT TO BOTH YOU AND THE TOWN OF WATERTOWN.**
- **ALWAYS INCLUDE A TELEPHONE NUMBER WHERE YOU CAN BE REACHED.**
- **DO NOT USE CASH FOR REAL ESTATE TAX PAYMENTS.**

Dog Licenses - All dogs over 5 months of age must be licensed. The license period is January 1 to December 31. Dog licenses may be obtained starting mid-December.

Dog License Fees:

- Spayed Female or Neutered Male \$ 5.00
- Unaltered Male or Female \$10.00
- Kennel license (5 – 12 dogs) \$50.00
- Late Fee – per animal (after 3/31) \$ 5.00

Complete the license application form below and attach a copy of the current rabies certificate. **If a rabies certificate is not provided, you will NOT be issued a license.** Please note, the rabies certificate must identify the dog vaccinated. Documentation should also confirm spay or neuter status. For license requests by mail or drop off remember to enclose a self-addressed, stamped envelope for mailing your license to you.
